



# LEMON DISINFECTANT

Use **LEMON DISINFECTANT** as a disinfectant on hard, non-porous, non-food surfaces. Use for non-scratch cleaning of showers and tubs, shower doors, fixtures and toilet bowl exteriors. Use to clean and disinfect sealed finished floors, sinks and tubs. Use with a mop and bucket, trigger sprayer, sponge or by soaking.

Use **LEMON DISINFECTANT** in: Health care facilities, Restaurants [Front of House], Schools, and Institutional facilities. Cross-contamination is of major housekeeping concern. **LEMON DISINFECTANT** has been formulated to aid in the reduction of cross-contamination between treated surfaces not only in hospitals, but in schools, institutions and industry.

Use **LEMON DISINFECTANT** on washable hard, non-porous surfaces of: bathroom fixtures, floors, and non-critical medical equipment surfaces: medical examining tables, medical lamps, rescue tools, resuscitators, medical scales, stands, stretchers, stethoscopes, walkers and wheelchairs. Other hard, non-porous surfaces made of: plastic and stainless steel.

**LEMON DISINFECTANT** is a disinfecting auto cleaner. Use **LEMON DISINFECTANT** in cars, buses, campers, emergency vehicles, taxis, trailers, boats, airplanes, and transportation terminals.

**LEMON DISINFECTANT** can be used on hard, non-porous surfaces of: dashboards, instrument panel, doors, door handles, gauges, steering wheel, and gear shifters. Surfaces include: metal, plastic, laminated surfaces, upholstery, vinyl and plastic.

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Before use in federally inspected meat and poultry food processing plants and dairies, food products and packaging materials must be removed from the room or carefully protected.

#### DISINFECTION / VIRUCIDAL\* / FUNGICIDAL / MOLD AND MILDEW CONTROL DIRECTIONS:

Apply **LEMON DISINFECTANT** undiluted to hard, non-porous surfaces, thoroughly wetting the surfaces, with a cloth, mop, sponge, sprayer or by immersion. Treated surfaces must remain visibly wet for 10 minutes. For **Influenza Virus Type A and Human Coronavirus and SARS-CoV-2**, treated surfaces must remain visibly wet for 1 minute. Wipe dry with a cloth, sponge or mop or allow to air dry. For visibly soiled areas, a preliminary cleaning is required.

For sprayer applications, use a coarse spray device. Spray 6 - 8 inches from surface. Avoid breathing spray.

Rinse all surfaces that come in contact with food such as countertops, appliances, tables and stovetops with potable water before reuse. Do not use on utensils, glassware and dishes.

For fungicidal activity, **LEMON DISINFECTANT** is an effective one-step fungicide against Trichophyton interdigitale when used on hard nonporous surfaces in areas such as locker rooms, dressing rooms, shower and bath areas and exercise facilities. Allow surface to remain visibly wet for 10 minutes.

For mold and mildew: Repeat treatment every 7 days or more often if new growth appears.

This product is not for use on medical device surfaces.
